Each year, publishers release new editions of classic reference resources to reflect changes. The goal of the Library System is to provide the most current information possible. To balance annual costs with providing the most up-to-date material, libraries may purchase more expensive resources on a schedule of every 2-3 years and stagger them across the system. Less expensive reference resources may be purchased annually. Suggestions from the public for purchase or retention are welcomed and given serious consideration.

(Library or system) is committed to providing the people of our community with library materials that meet their informational, educational, cultural, and recreational needs. To this end, the Department of Community Services has established policies and procedures for developing and maintaining the collections of its libraries.

Suggestions from the public for purchase or retention are always welcomed and given serious consideration. The library may remove some material as demand for items declines; or as they become damaged, worn, or obsolete.

Geographic features and regions occasionally are renamed or changed. Each year, publishers release new editions of classic reference resources to reflect these changes. "The Gulf of Mexico is an international body of water. Some resources from outside the United States are not obliged to comply with executive orders and may still refer to the former name."

To balance the annual cost with providing the most up-to-date material, most libraries in the system purchase the more expensive resources on a schedule of every 2-3 years and stagger them across the system.

Other resources are less expensive, such as The World Almanac or Book of Facts. These may be purchased annually as released by the publishers.

Please note, even new 2025 editions may be out-of-date by the time a book reaches the printing stage of publication. Publishers set their own timeline for releasing products. Online editions of resources may be more current.

While we adhere to professional cataloging standards, we recognize that additional information or a change in information regarding a library item may be warranted.

The Delaware Library Catalog uses the Library of Congress Authorities and Library of Congress Subject Headings (LCSH) to describe and refer to geographic locations. The Library of Congress subject headings are not locally determined. They are controlled by the Library of Congress. Congress controls the Library of Congress' funding, and the Librarian of Congress serves at the pleasure of the President of the United States.

Proposals to change a LCSH require supporting documentation often including definitions of the term, its variations in reference sources, its relationship to other existing subject headings, and evidence that the term is both historically accurate and the predominant term currently in use. Once approved, the Library of Congress Subject Authorities are updated weekly. As the Delaware Library Catalog updates authority records quarterly, some may temporarily be out of sync.
